Terms and Conditions for Win a Polestar 4 Shell 2025 lucky draw

Mechanics of Promotion

- 8. Qualifying Purchases
 - To qualify for one (1) Lucky Draw entry, Eligible Customers must make a qualifying purchase of minimum S\$15 gross spend (i) on Shell FuelSave 98, Shell FuelSave 95 or Shell FuelSave Diesel (collectively, "Shell Fuels"), (ii) on any items at a Shell Select store (save and except for any tobacco products or service items), or (iii) at a Shell Car Wash; or
 - ii. To qualify for two (2) Lucky Draw entries, Eligible Customers must make a qualifying purchase of minimum S\$15 gross spend (a) on Shell V-Power or (b) on EV car charging at any Shell Recharge locations in Singapore or (c) by making any of these Qualifying Purchases through the Shell SmartPay function in the Shell Asia App.

12. Biweekly Draw
